Each member introduced themselves and shared 2-3 community accomplishments they are proud of from the past several years, including:

- Significant progress in new housing developments and infrastructure for infill opportunities
- Attraction of new businesses and expansion at the industrial park
- Continued momentum in downtown revitalization since 2016
- Voter approval and successful implementation of a \$40 million school bond for the expansion of the elementary school facilities. This was the first bond of that size to pass in Nebraska, funding new additions and significant improvements to accommodate growth and enhance educational quality in the community
- Strong collaboration between city departments and community organizations
- Growth of the healthcare system, including new facilities and services
- Establishment and success of the Creative District, with events like adult prom, Mardi Gras, and cultural festivals
- Investments in public spaces such as street resurfacing, East Hill Park cleanup, and Christmas decorations downtown
- Trail and community center improvements
- Initiatives to strengthen the connection between York University and the community
- Expansion of local childcare options, especially linked to workforce retention and healthcare services
- Development of new senior housing options and interest in mid-range rental housing
- Public interest in expanding local sit-down restaurant offerings to support residents and sports tourism
- Growing focus on improving public transportation options, especially between downtown and the Tower Crossing district
- Housing development and reinvestment in existing homes
- New industrial park and business recruitment

- Downtown revitalization
- Elementary school bond approval
- Healthcare system growth
- Creative district activities and cultural events
- Street improvements and park upgrades
- Growing university-city collaboration

III. Overview of York's Comprehensive Plan Update Agenda Item Type: Information Item

Amy Haase and Flavia Tourek provided an overview of the plan:

- Builds on the 2017 plan and recent studies (e.g., Tower Crossing Master Plan)
- Focus areas include land use, housing, economic development, infrastructure, and community livability
- Strategic in nature; not starting from scratch
- Steering Committee role is to guide, review, and advise
- Project runs through December 2025 with additional meetings scheduled for July, September, and November

VI. Community Priorities and Discussion

Agenda Item Type: Discussion Item

The committee was asked to identify York's **top three priorities** for the next ten years. This generated a rich discussion on community needs, challenges, and opportunities.

Topics raised during discussion included:

- Ongoing housing needs across income levels, including demand for apartments, midrange housing, and senior housing that is affordable but not entry-level or custom-built
- The importance of infill development and opportunities tied to underutilized or former school sites
- Limited availability of first-time homebuyer housing and the importance of turnover in existing housing stock
- Expanding rental options, including mid-term rentals for professionals or new residents transitioning into homeownership
- Childcare access and its impact on workforce recruitment and retention, especially in healthcare and other major employers
- Public transportation gaps, particularly between residential areas and employment centers like the Tower Crossing District, and interest in developing consistent city routes or park-and-ride options
- Demand for additional sit-down restaurants, particularly to serve visitors during weekend sports tournaments and to attract traffic from the interstate
- Speed and safety issues near university housing, with specific concern about high-traffic corridors used by students, families, and park-goers
- Infill development opportunities, including addressing vacant or problem properties and exploring redevelopment of key sites
