#### TABLE REZONING REQUEST

The Chairman announced that this was the time and place set for a public hearing on a request filed by the IOOF to zone the Northeast Quarter of the Northeast Quarter, except railroad right of way and except Irregular Tracts # 19, # 18 and # 7 and part of # 22 and except a .44 acre tract in Section 12, Township 10 North, Range 3 West of the 6<sup>th</sup> P.M., City of York, York County containing 13.25 acres from Residential to Agriculture. Jerry Staehr addressed the Commission stating that he has been farming this area for several years and due to the fact that this is zoned Residential the real estate taxes run about \$3800/year. A letter from the City Attorney was presented wherein it is stated that since the surrounding lands are zoned residential and C-2 and that the comprehensive plan does not provide for this to be an agricultural use, he would be concerned that this request would be spot zoning and would not be appropriate. Rex Rasmussen spoke in support of the application. The issue of spot zoning was addressed by the Commission.

The Chairman closed the public hearing.

Nickel move and Ronne seconded to table this matter until it can be determined if the Comprehensive Plan can be amended to allow this use.
